The Parish Councillors were supportive of this but will request the already agreed 40 mph speed limit at the end of Russell Hill towards the A47 is also included in the proposals)

9. GRASS VERGES

It was noted that traffic cones have been placed on the grass verge outside St Andrew's Church which has deterred motorists from parking their vehicles at this location.

It was noted that dog walkers need to be more visible during the winter evenings and should be encouraged to wear high visibility jackets and carry a torch.
