1. APOLOGIES FOR ABSENCE

There were apologies for absence from Mike Kealey, Alan Frost and Gavin Elsey

2. DECLARATIONS OF INTEREST

There were no declarations of interest.

6. MATTERS ARISING

i) Highway Issues

The Chair attended a meeting at Sacrewell along with Sam Carling, MP, other Parish Councillors and other interested bodies to discuss the safety concerns along the A47 that will remain now that the plans to dual the A47 between Wansford and Sutton have been dropped. The Parish Councillors expressed disappointment that over £10 million had been spent on preparing for the dualling of the A47. The consensus was that it was unlikely that National Highways would undertake any safety work on the A47, but a further meeting is planned to pursue the concerns.

ii) Social Events

Nicky Rogers will confirm the Wansford Ukelele Band's attendance on the Christmas Lights' Switch-On. The arrangements for the Christmas Lights' Switch-On and the Christmas Party will be finalised at the next meeting.

iii) Defibrillator Training.

The Clerk had booked St John's Ambulance to give a First Aid and Defibrillator Training Course for twelve residents. However, disappointingly, only one resident had said they wished to attend. The Clerk will ascertain any costs of rescheduling the event but if there are costs, the event will go ahead anyway. Nicky Rogers will undertake a leaflet drop in the village over the weekend and will attend the Coffee Morning on Friday. It was noted that the Parish Council does not have any yoga mats to use during the training.

iv) Thornhaugh Neighbourhood Plan

Mike Kealey was not present so there was no update. It was agreed that it is likely that there will be difficulties in getting the plan off the ground as it must be undertaken by a committee of residents rather than Parish Councillors, although a Parish Councillor can be on the committee.

The Chair proposed that the Parish Council moves to a .gov.uk domain and this was seconded by Yana Clipsham and agreed to by all present. Jay Allsopp, Website Designer, has agreed to undertake this work for the Parish Council. The Clerk will invite him to attend the next meeting.
