1. APOLOGIES FOR ABSENCE

There were no apologies for absence.

2. DECLARATIONS OF INTEREST

There were no declarations of interest.

3. PUBLIC FORUM

The Members of the Public did not have any issues to raise that were not already on the Agenda.

4. POLICE MATTERS

There were no reports of crime in the village. The problem of scrambler bikes illegally entering Thornhaugh Quarry was noted. The second ram raid on Wittering Community Shop in less than a month was noted.

6. MATTERS ARISING

i) **Highway Issues including road condition on entrance/exit to Thornhaugh Village**

Several residents had reported the potholes to Fix My Street (Peterborough City Council). It was noted that the sides of the passing areas on Russell Hill are very muddy and falling apart at the edges. The Clerk will report to the Highways Department at Peterborough City Council.

ii) **Social Events 2026**

It was agreed to hold a Summer Party on possibly 18th August 2026 (if the date is convenient to Alan and Joan Frost whose garden will be used). It was also agreed to hold the Christmas Tree Lights Switch-On on 6th December and the Christmas Social on 18th December 2026.

iii) Thornhaugh Neighbourhood Plan

Simon Scriven, Chair of Sutton Neighborhood Plan, has provided excellent information regarding the process that Sutton Parish Council has gone through. It was agreed that a Launch Meeting needs to be organised as soon as possible. Paul Whybrow, Mike Kealey and Nicky Rogers will meet to progress this. A Skills Audit needs to be undertaken to establish if there are any residents with IT Skills, PR & Communication Skills, etc, who may be willing to join the group.

iv) IT Policies

Jay Allsopp had circulated a written summary of the options to the Parish Councillors. All three suppliers meet the requirements. It was agreed to go ahead with Aubergine plus Option 2 Microsoft 365. Jay kindly offered to move all the existing information on the current Website, eg Agendas and Minutes, across to the new Website. Jay was thanked for all his efforts.

It is envisaged that Sam will start on 1st March 2026 to allow sufficient handover time between the old and new Clerks.
